 - 1. There has been some struggle with students getting back to us
 - 2. Will likely not have a show this year

 - 2. Seemed to be beneficial for those students that attended

 - 1. A volunteer from the class has taken charge

3. Student Faculty Show

a. Reschedule to January (Not April) - reminder!!

4. Dean Kitaw Demissie

a. As of January 1st

- i. The hospitalization rate of those with Omicron has been decreasing
- ii. Our hospitalization rate is around 15%
 - 1. It has reached its peak and now is decreasing
- iii. Campus trackers are working to be effectively contact tracing
- iv. The guidelines that we are following are the CDC guidelines
 - 1. The infectivity is a day before symptoms
 - 2. We are isolating those showing symptoms
 - a. 5 days as far as staff and faculty
 - b. Students are being asked to isolate for 7 days
 - c. Permitted to return given that they have not shown any symptoms in the past 24 hours
 - d. Those that are tested positive we require testing at days 3,5 and 7
- v. We ask students to use K95s of N95s for an additional 3 days once they return to campus
- vi. Masks are considered mandatory at downstate
- vii. Omicron is considered mild in terms of hospitalization and death amongst those people that are fully vaccinated and the individuals that are boosted are showing the most protection
- viii. Contact Tracing
 - 1. There are those who were once part of the school of public health that now are working full time to oversee contact tracing
- ix. Pool Testing
 - 1. Those that test positive are immediately contacted
 - 2. Putman, student and faculty health, contact tracing all meet daily at noon to stay on the same page with Dean Brunicardi
- x. Booster
 - 1. Is there a deadline as to when boosted will be required for students?
 - 2. The confusing piece to this is that there are two booster rules
 - a. General SUNY/CUNY student rule
 - i. If you are eligible for a booster as of January 15th then you have until Feb 15 to get the booster
 - ii. If you are not eligible as of January 15th (after 5 months of Fizer or moderna, or 2 months after johnson and johnson)
 - 1. Then you have one month from the date that you become eligible to receive the booser
 - b. Second rule for healthcare institutions
 - i. Released by the governor
 - ii. Waiting for the final written rule with dates written in
 - iii. We do not have this information yet
 - iv. Whichever rule is stricter is the one the downstate community must follow
 - 3. A memo will be sent out to students with the most recent and accurate information depending on what information we have

received

- 4. The booster will be required at some point after you are eligible to getting the booster
- 5. Students should not wait for february 12the for students
- 6. Submit to red cap as soon as you can
- xi. Student Concerns
 - 1. Ineffective contact tracing
 - a. PBL's and other student groups are not being notified of COVID exposure in a timely manner.
 - i. Contact tracing has been backed up.
 - ii. We were not prepared for the influx of positive cases in January
 - iii. We have recruited more workers to make sure contact tracing continues smoothly.
 - b. Once a student is found out to be positive, they are unsure who to contact.
 - c. Getting N95s/KN95s are not easy they are expensive and hard to come by
 - i. Student health can give you an N95
 - 2. This is a very reactionary response as opposed to a preventative response
 - a. This is because of the fact that we were not prepared
 - b. We were definitely overwhelmed but have recruited more workers to ensure students remain safe
 - 3. It may be good to have an open form for students to express their opinions on returning back to campus.
 - a. Concern of students that are immunocompromised returning to campus or those with family members with compromised health.
 - b. Common consensus amongst healthcare leaders in the county is that omicron is not a virulent version
 - i. We are not virgins to the virus
 - ii. Almost everyone is vaccinated at home
 - iii. Those that are vaccinated are not going to be hospitalized by this virus
 - iv. THESE decisions are made by the chancellor and other SUNY authorities
 - c. We are evaluating each piece of your education, weighing your safety and the value of your education
 - i. For example, this week for the MS2s we transferred an event to online because of students (50+) being in a small
 - d. These are all decisions being made with your safety prioritized
 - i. We also have been looking to other schools to see how they are responding to the pandemic
 - ii. SBU etc are in person since break
 - 4. The educational leadership team, deans, contact tracing, all meet

steadily, daily if not multiple times a week to provide safety for students

- 5. The things that need to be virtual are being done in person and the things that need to be done in person are being done virtual
 - a. We understand that you are trying to prioritize our education but the wrong modalities are being prioritized
- 6. The Class of 2025
 - a. 70% of the class feels not safe coming in this coming tuesday
 - b. 30% of people who said they would want to come back is solely for anatomy
- 7. If you are unconcerned that you are positive
 - a. You can contact the COVID email
 - b. You will be excused from class until you get a negative test
 - c. Students that are exposed to positive if you were cin contact with a positive case
 - i. If you were asymptomatic and exposed you are still considered fine - to come in according to CDC guidelines
- 8. Exam week may need to change soon not all of it can be done this way
- 9. Will MS2s be pulled for random testing during dedicated
 - a. Random pool sample is a spreadsheet where each of you were assigned a random number
 - b. It is possible that you would get an email from me saying that you have been selected
 - c. But all you would do is that you select that you are not on campus this week
 - d. If you are coming in to campus everyday to study then

 - a. These students can submit forms directly to
