Meeting Minutes:

Meeting called to order at 12:45pm by Nicholas Lazzaro, SOHP Council President and Jane Sato, SOHP Council Secretary seconded the motion to begin the meeting. Adam Burgman was present throughout the meeting as SOHP Council faculty advisor, Dean Phillip Bones, was unable to attend.

1. After discussion with Adam Burgman, the following motion was made by Nicholas Lazzaro, and 2nd by Jane Sato:
 - a. **Motion:** To approve and add a speaker honorarium request, amended from Med and UHC Council for SOHP use.

Jane Sato, SOHP Secretary, will organize the speaker honorarium event. The speakers have a unique skill set and would present on disability advocacy. Funds for this event will be allocated from 40-70173-010-30001 (PROGRAMS AND PROJECTS).
 - b. Motion passes 9 YES – 0 NO – 0 Abstaining.
9. Finals breakfast announced and planned for April 28th at 8:30am in the Alumni Atrium. Jane Sato, secretary will send room request to Adam.
10. Announcements about SOHP Student Council nominees and election during the next meeting.



