SUBJECT: UC Budget Revised Certification for FY 2021 (6/1/20 thru 5/31/21).

Attached is a copy of UC's certified budget for Student Activity fees (SAF) for the fiscal year 2021 that began June 1, 2020. The UC had submitted and voted to refund 80% of the Fall 2020 SAF at their February 18, 2021 meeting. The UC Budget, which has been modified as needed and certified on behalf of the Campus President in accordance with the SUNY Board of Trustees Guidelines with the following adjustments:

- Activities Fee Income: The UC's prior budgeted FY2021revenue for was \$ 34,030.04. is revised to \$18,972. This reflects UC's refund of 80% of Fall 2020 Student Activity Fee (est total \$15,058). Full time students to receive refund of \$8; prorated for Part time students).
- <u>Programs & Projects</u>: The net of the above revision results has been made in this account being adjusted to \$13,114.78 in order to balance UC's budget (bottom line net to zero).

Please be aware that:

- Authorized Signators: the UC Constitution requires joint signatures on payment requests co-signed by the Treasurer and one other UC officer. Club funds require UC Treasurer plus one other club officer's signature.
- **Expenses** may be drawn from appropriate accounts in accordance with this certified budget, dependent on the positive cash balance of the account at the time of disbursements.
- **Programs & Project's** account requires UC meeting minutes approving each use, since purpose is undesignated at this time of certification.
- The Council may submit a revised budget for additional certification at any time during the year.
