Reports will be made public to Downstate students and staff. 7-8 people to address areas of the university will conduct a review and make a final report.
 - i. the review official has not yet been assigned to our campus
 - ii. they will review our submission, identify errors with our submission, give us an opportunity to revise, the middle states commission will review the final report, and then give us a judgement

- iii. in the past middle states has most cited the use of outcomes assessments to guide future practices
- b. CCMP- would like to connect with members of our community
 - i. Where can they table? (They want to work with Downstate and see if they can table with us) → pass out postcards and mail out postcards to representatives to avoid closing down hospitals

- a. COM: There is frustration among the student body regarding the school's recent policy to implement CBSE before dedicated that needs to be passed with a certain score before you sit for step 1. This is because of the low pass rates in COM 2026. Failing CBSE attempts will cause an automatic failure for Gateway 2. Students feel that this is meant to scare them to study earlier. Elana: Med Council covered study resources for everyone.
