Student Learning Assessment Policy	<ul> <li>Student learning Assessment policy comments included:</li> <li>Discussions on using the policy to inform assessment procedures in areas that do not have a separate accrediting body</li> <li>Adding more explicit language on who uses the results to enact changes "Deans, senior leaders, and their designees will use the result of assessment results for the improvement of"</li> <li>Removing section on roles and responsibilities and add language on designation of assessment point person from each school/college. "Each College and School will identify a person who is responsible for assessment and accreditation activities in their respective College or School and who will serve as the liaison to the EOAA for assessment and accreditation activities."</li> </ul>

Assessment Plan Template	<ul> <li>Clarifying that School/colleges with an existing assessment plan based on their accrediting body do not need to reproduce their plan in the new format. However, their plans should include all the same components and documentation that are expected in the approved Downstate template. To demonstrate alignment with the expectations, Colleges and Schools that have existing assessment plans for their programs should share each plan, include the Downstate assessment plan template as a cover page, and cite the relevant pages from their existing plan in the assessment plan template. Effectively, the resulting assessment plan as provided to EOAA will be a collection of citations to their existing assessment plan plus the relevant curriculum map(s).</li> <li>Motion made to approve assessment plan template with suggested changes By Tracy</li> </ul>

If programs have assessment results prior to 2017, those will also be helpful in demonstrating Downstate's long-standing assessment practices (for example, Nursing has records starting in 2017 and SoHP has records starting in 2021)</li> </ul>
