The DNP program at SUNY Downstate Health Sciences University, College of Nursing (CON) is designed to prepare nurses for the highest level of nursing practice in order to positively affect the triple aim of healthcare; improving patient outcomes, decreasing healthcare cost, and improving patient satisfaction. The DNP program is intended to prepare students to lead healthcare innovation, influence healthcare and health outcomes for all populations in a variety of practice settings.

The post-baccalaureate DNP Program is cohort based, 76 credits, and 10 terms in length. Students who hold a Master's degree, APRN certification (FNP or WHNP specialties), and meet admission requirements will be considered for advanced standing, allowing them to complete the DNP Program in 7 semesters (46 credit hours).

Admission Requirements

BS to DNP (FNP or WHNP Concentration)

- **Bachelor of Science degree in Nursing** from colleges or universities accredited by one of the following: The Middle States Commission on Higher Education (MSCHE), the New England Commission on Higher Education (NECHE), The Higher Learning Commission (HLC), the Northwest Commission on Colleges and Universities (NWCCU), the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC), the Western Association of Schools and Colleges (WASC) Senior College and University Commission (WSCUC) or the Accrediting Commission for Community and Junior Colleges (ACCJC), United States Department of Education (USDE).
- A current unencumbered New York State R.N. license.
- A current American Heart Association (AHA) card/certificate for *BLS for Healthcare Provider* or *ACLS*.
- You must submit two (2) letters of recommendation. One letter must be written by: A current/former supervisor within the past 3 years, who can comment on your clinical abilities and/or your potential success in graduate nursing education; the second letter can be written by an additional supervisor or a current/former college university science professor within the last 3 years.
- One (1) year clinical experience post baccalaureate degree is preferred.
- Cumulative Grade Point Average (GPA) of 3.5 on a 4.0 scale preferred.
- Curriculum vitae/Resume.

NOTE: All admissions requirements must be completed at the time of applying and candidates who meet admissions requirements may be called for an interview.

MS to DNP (Post Master's DNP)

- **Master of Science degree in Nursing** from colleges or universities accredited by one of the following: The Middle States Commission on Higher Education (MSCHE), the New England Commission on Higher Education (NECHE), The Higher Learning Commission (HLC), the Northwest Commission on Colleges and Universities (NWCCU), the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC), the Western Association of Schools and Colleges (WASC) Senior College and University Commission (WSCUC) or the Accrediting Commission for Community and Junior Colleges (ACCJC), United States Department of Education (USDE).
- You must submit two (2) letters of recommendation. One letter must be written by: A current/former supervisor within the past 3 years, who can comment on your clinical abilities and/or your potential success in graduate nursing education; the second letter can be written by an additional supervisor or a current/former college university science professor within the last 3 years.
- Cumulative Master's level Grade Point Average (GPA) of 3.0.
- Current unencumbered New York State R.N. license.
- Current unencumbered New York State Nurse Practitioner license in the specialty of either Family Health or Women's Health.
- A current American Heart Association (AHA) card/certificate for *BLS for Healthcare Provider* or *ACLS*.
- Curriculum vitae/Resume.

NOTE: All admissions requirements must be completed at the time of applying and candidates who meet admissions requirements may be called for an interview.
