The Women's Health Nurse Practitioner program (WHNP) provides comprehensive, culturally sensitive primary health care, through a holistic perspective that emphasizes health promotion and disease prevention to women throughout the lifespan.

The advanced certificate program of study is 35 credits and designed to be completed in three to five semesters depending on previous coursework. The WHNP is prepared to implement evidence-based practice guidelines, critically analyze and implement health care interventions based on individualized assessments of women's health care needs.

As advanced practice nurses, Women's Health Nurse Practitioners perform comprehensive health assessments; conduct risk analyses; provide client education and counseling to promote wellness and prevent disease; diagnose and treat common health problems and acute and chronic conditions. The primary

focus of the care provided by the Women's Health Nurse Practitioner program is in the area of Obstetrics & Gynecology.

The curriculum of the WHNP program is based on the American Association of Colleges of Nursing's Essentials document. It also meets the guidelines of the National Association of Nurse Practitioners in Women's Health.

Graduates of the program are eligible to apply for licensure in New York State and to sit for the national certification examination given by the National Certification Corporation (NCC) which is the certifying body for the Obstetric, Gynecologic and Neonatal advanced practice nurses.

Admission Requirements

- **Master of Science or doctoral degree** from colleges or universities accredited by one of the following: The Middle States Commission on Higher Education (MSCHE), the New England Commission on Higher Education (NECHE), The Higher Learning Commission (HLC), the Northwest Commission on Colleges and Universities (NWCCU), the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC), the Western Association of Schools and Colleges (WASC) Senior College and University Commission (WSCUC) or the Accrediting Commission for Community and Junior Colleges (ACCJC), United States Department of Education (USDE).
- A current, unencumbered New York State R.N. License.
- You must submit two (2) letters or recommendation. One letter must be written by: A current/former supervisor within the past 3 years, who can comment on your clinical abilities and/or your potential success in graduate nursing education; the second letter can be written by an additional supervisor or a current/former college university clinical nursing professor within the last 3 years.
- A current, unencumbered New York State Advanced Practice Clinical Nurse License (APRN).
- A current American Heart Association (AHA) card/certificate for *BLS for Healthcare Provider* or *ACLS*.
- One year clinical experience post baccalaureate degree is preferred.
- A cumulative Grade Point Average (GPA) of 3.0 on a 4.0 scale is preferred.
- General Chemistry w/lab (3–4 credits) with a minimum a grade of "C."

NOTE: All transcripts are evaluated for previous academic performance. All admissions requirements must be completed at the time of applying and candidates who meet admissions requirements may be called for an interview.

Advanced standing is available to applicants who already hold a Master of Science degree in an advanced practice nursing role and wish to earn an advanced certificate as a Women's Health Nurse Practitioner. Individual program plans will be developed to maximize students' educational and work experience toward fulfilling program requirements. Up to 24 of the 36 credits required for the certificate may be transferred or challenged by examination. An administrative fee is required for the challenge examination.
