To ensure all staff involved in CT receive <u>Annual Safety Training and comply with all Regulatory Educational requirements.</u>

II. DEFINITION:

None

III. RESPONSIBILITIES

Radiation Safety Officer (RSO), Medical Radiographer. Technologist and Attending Radiologist and/or Radiology Residents

IV. POLICY

All CT Technologists are required to maintain all educational requirements as specified by the ARRT/Joint Commission and NY State.

V. PROCEDURE/GUIDELINES

- All CT Technologist will attend an annual safety training seminar provided by the Radiation Safety Officer.
- All CT Technologist will maintain ASRT CE Requirements.
- ARRT & ACR recommends certification in CT for Technologist performing CT exams
- All CT Technologist will complete at least <u>6 CT related ASRT</u> directed readings during the 2nd. Year period.
- All CT technologist will participate in on-going education specifically in dose reduction practices. i.e., Image Gently and Image Wisely -
- All CT technologist will be required to complete annual competency re-assessment to include CT scanning techniques and performance of Daily and weekly QA.
- All CT technologist must maintain a valid BCLS certification.
- All CT technologist will maintain certification in IV insertion.
- All CT technologist will complete an annual IV insertion competency exam.
