

Mandatory Professional Licensure Disclosure SUNY Downstate Health Sciences University College of Medicine April 2025

Effective July 1, 2024, federal regulations require institutions of higher education to make a determination whether a Title IV eligible academic program that leads to professional licensure or certification meets the educational requirements for licensure/certification in the U.S. State where the institution is located and the U.S. States where "distance education" students are located at the time of initial enrollment in the program, as well as U.S. States where the program is advertised as meeting such requirements, and if applicable, the U.S. State where students attest they intend to be licensed/certified. The Doctor of Medicine program at SUNY Downstate Health Sciences University is registered by the New York State Education Department and thus meets the educational requirements for licensure/certification in the State of New York.

Through a good faith effort, and for the purpose of complying with the federal regulation, we have determined that the Doctor of Medicine program at SUNY Downstate's College of Medicine meets the educational requirements for licensure/certification in the following U.S. States and Territories; however, it is important to note that SUNY Downstate Health Sciences University is not the licensure/certification authority in these U.S. States and Territories and cannot assess whether an individual candidate will be issued a license/certificate in these U.S. States and Territories and instead it is incumbent on each individual candidate to contact the licensure/certification authority in the applicable U.S. State or Territory for any further guidance on the requirements for licensure/certification processes.
