For the protection of its citizens, each license and certificate has requirements that individuals must meet in order to be licensed or certified in New York State. Thus, each of SUNY's academic programs that lead to licensure or certification are carefully designed to meet and exceed these State requirements. This is the role the SUNY system plays in protecting the public.

Per U.S. Federal Regulations, [34 CFR §668](#), and in compliance with the [State Authorization Reciprocity Agreements \(SARA\) Manual version 24.2, December 16, 2024](#), SUNY Downstate provides this disclosure related to the educational requirements for professional licensure and certification for academic programs leading to professional licensure to meet the educational requirements for licensure in states where SUNY Downstate students reside. This disclosure does not provide any guarantee that any particular state licensure or certification entity will approve or deny your application. Furthermore, this disclosure does not account for changes in state law or regulation that may affect your application for licensure and occur after these disclosures have been made.

This Disclosure is strictly limited to SUNY Downstate's determination of whether its educational programs, **Bachelor of Sciences in Diagnostic Medical Imaging-Sonography; Master of Science and Advanced Certificate in Midwifery; Masters of Science in Occupational Therapy; Bachelor of Science/Doctor of Physical Therapy in Physical Therapy; Master of Science in Applied Behavior Analysis; and Master of Science in Physician Assistant** - that if successfully completed, would be sufficient to meet the educational licensure or certification requirements in New York State.¹
