It is suggested that participants enroll in Adult Education Basics courses in sequential order.

**Required:** Three-hour commitment each day from course participants with approval by supervisors.

**NOTE:** An optional orientation for Canvas will be held during the week prior to the start of class. Students will be contacted directly to attend this after they are enrolled in the course.
