The IACUC review process cannot be expedited or modified per federal regulation ([NOT-02-0064](#)), ([PHS Policy Section IV.C.2](#)). The IACUC may choose to review any submission at a convened meeting. These submissions are designated as Full Committee Review (FCR). Submissions of increased complexity and concern have a higher likelihood of being designated for FCR.
