At least seven (7) primary members (or their alternates) must be present for a quorum for each meeting. A non-scientist must always be present to achieve quorum. An MD must be present for FDA regulated research.

The primary member for the month will vote at the meeting. However, if the primary member is absent or recused, the vote will go to the alternate member, if present.

When only the alternate member within a voting group receives a review assignment for an agenda item and when he/she is present for the convened meeting, his/her vote will count towards the motion of that item, rather than his/her corresponding primary member.
