FEE SCHEDULES FOR INDUSTRY SPONSORED, SIRB REVIEWED, AND EXTERNAL IRB REVIEWED RESEARCH

- 1. Research budgets must include <u>all IRB</u> fees:
 - a. The PI is responsible for including <u>all</u> Downstate IRB fees in research budget and must indicate whether fees are paid out of the research budget or if they will be invoiced directly to the sponsor or CRO.
 - b. Industry funded research budgets are reviewed and approved by the WCG Clinical (not WCG IRB) on behalf of the RF.
- 2. Invoices for IRB fees:
 - a. The WCG Clinical will automatically invoice Downstate IRB fees on behalf of the RF upon study start up.
 - b. The Downstate IRB Office will notify SPA when a study is approved or activated for reconciliation and tracking purposes.

Invoice	Downstate IRB Review Types: Industry sponsored studies (e.g., for profit company or public entity), that are not otherwise reviewed by the WCG IRB or Other Reviewing (External) or Central IRB.	WCG IRB (as sIRB or Central IRB) Required for: 1) Industry sponsored clinical investigations, or 2) Federally funded non-exempt human research which requires a Single IRB (sIRB) when Downstate is the Primary awardee and multiple sites are engaged in human research. Optional for: Other multisite studies. Notes: The PI must confirm the Reviewing IRB bills the sponsor for IRB fees. For sIRB	Other Reviewing (External) or Central IRB Can be used for multi-site studies when 1) the Sponsor or CRO does not agree to use the WCG IRB or 2) when Downstate is not the Primary awardee and the grant requires a different sIRB. Notes: The PI must submit documentation to the Downstate IRB indicating the WCG IRB cannot be used. The PI must confirm the Reviewing IRB bills the sponsor for IRB fees.

To obtain a quote for sIRB fees for specific study, submit the WCG Single IRB Quote Request Form If the sponsor cannot be directly invoiced, the WCG IRB will invoice the PI for which SPA will impose an additional 25% processing fee.
